## Instrument of Authorization

### Requirement to tell a student about a suspension and exclusion under Chapter 12, Part 3, Division 3 of the *Education (General Provisions) Act 2006 ('EGPA')*

I, Gabrielle Douglas, Acting Principal of Glass House Mountains State School, **authorise** the persons who are from time to time the holders of the position of Deputy Principal at this school to tell a student on my behalf of my decision to suspend the student under section 293 of the EGPA.

I further authorize the persons who are the holder of the position of Deputy Principal to tell a student of my decision not to exclude that student under section 295(2)(a) of the EGPA. This authorization includes telling the student that their suspension under section 293 has ended and the student may resume attendance at the school.

A Deputy Principal who tells a student of my decision to suspend a student and/or my decision about their exclusion, acts in my name.

The effect of this authorization is as follows:

- A suspension of a student under section 293 of the EGPA will start when a Deputy Principal tells a student about my decision, as per section 293(3) of the EGPA;
- When a Deputy Principal tells a student about my decision not to exclude the student, and that the student's suspension has ended, and the student may resume attendance at the school, the student has been told in satisfaction of section 295(2)(a) of the EGPA.
